The Foundation shall serve to promote the value of a comprehensive educational program and to increase public confidence and involvement in the public school system. It shall build links among the public school system, business and industry, government, civic organizations, and the public.

DEAR FRIENDS OF LEAF



As a non-profit, LEAF strives to help District 742 meet the needs of its students. Changing times and changing needs have caused us to change and grow. As my time with the LEAF Board ends, I'm taking a trip through the history of LEAF and what it has been able to accomplish because of your generosity.

LEAF was founded in 1993 as an activities foundation, recognizing extracurricular activities are a vital component of education and student success. Our purpose was to raise money to help maintain activities, and we gave our first grants to District 742 in 1996. In 2001 we made our largest single contribution to District 742. When decreased state funding caused the District to consider eliminating middle school extracurricular programs; LEAF succeeded in raising \$140,000 to save them.

In 2009, LEAF accepted the challenge of providing supplemental funding for academic programs. We created the Academic Enrichment and Opportunity Fund, to enhance curricular and classroom opportunities for our students, and our first academic grant was awarded in 2010.

Since 2010, LEAF has grown and adapted to meet the changing needs of the District. Here are the new initiatives:

- Adopt-a-Classroom, 2012, because teachers often spend their own money to provide classroom supplies and materials. Donors "adopt a classroom" for \$250. The money is available to a selected teacher, to purchase needed items.
- PAKRAT (Partners and Kids Reading A lot Together), 2012, a literacy program for pre-school through 3rd grade. Students check out a book every night to take home to read. Parents, students, and teachers love this program. Both private foundations and individual donors have recognized the importance and success of this program with their donations (\$121,912 so far!).
- Roll and Read bus, 2013, an expansion of PAKRAT. The PAKRAT program works so well, we partnered with District 742 and community organizations to bring books to students in their neighborhoods during the summer.
- Immersion Program Fund, 2014, to help support the cost of materials, supplies, etc. for District 742's Chinese and Spanish Immersion Programs. These funds have supported Amity interns and bought instructional supplies and media in the target language.
- The Homeless Student Services Fund, 2014, to help provide basics for the homeless students in District 742 that are not provided by other local agencies. Because a child can't learn if his/her basic needs aren't met, it includes school supplies, clothing, food, and emergency housing assistance.

The new programs above developed as a response to changing needs. Our increasing growth is shown in the following numbers: LEAF has granted nearly \$1.4 million dollars to support the education of District 742 students since 1996; \$820,103 has been granted in the last six years. During that same time, our endowment increased by \$493,214.

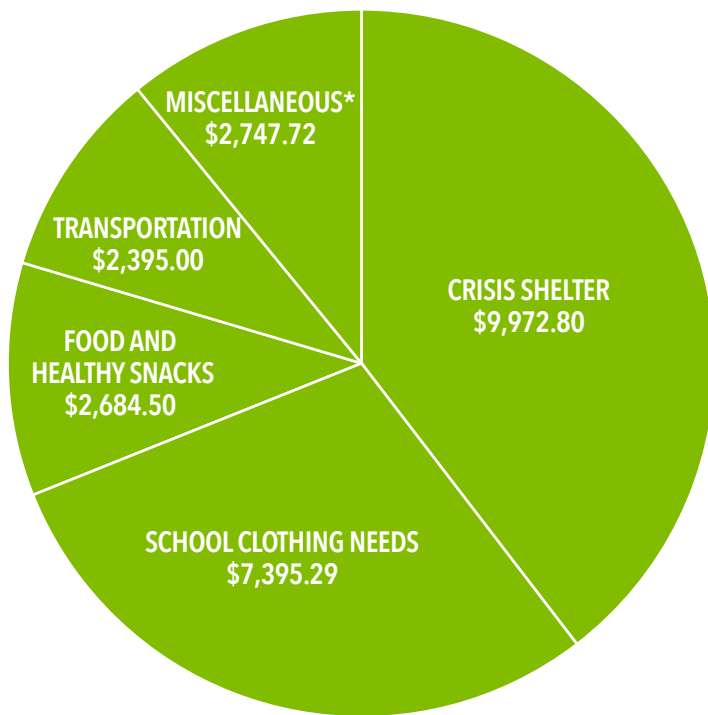

A GROWING FOUNDATION; A GROWING IMPACT

Over the past six years (FY12-FY16), LEAF has provided over \$820,103 in support to the District 742 academic, activities, arts and athletic programs! In addition during the same time period, LEAF has grown the endowed fund from \$562,780 to \$1,054,660 – a growth of \$491,880! With your help, LEAF will have an ever-growing, positive impact on the educational experiences for District 742 students! While LEAF supports all academic, activities, arts and athletics programming, we would like to highlight several programs that benefit students in need and accelerated learners.

HOMELESS STUDENT SERVICES FUND PROVIDES ASSISTANCE TO STUDENT IN NEED

Every day homeless students face the daunting task of focusing on a quality education while worrying about the basic needs of reliable shelter, clothing and food. In the fall of 2014, LEAF was approached by community members and school district homeless student social workers who asked if we would be willing to add a fund in support of these homeless students, to help ensure that they have a better opportunity for success in school. Local district and county resources and programs simply cannot meet all of the needs of our over 300 homeless students.

A fund was set up and a homeless student services fund committee, with representatives from LEAF, District 742 and the community began meeting. Through donations from individuals and businesses, the LEAF Homeless Student Services Fund has been able to grant \$25,195.31 to provide healthy snacks, school supplies, transportation, clothing, food and crisis shelter for District 742 homeless students as of December 1, 2015. The district homeless student social workers turn to the LEAF fund only after all community and social service resources have been tried.

Throughout the country, as well as in District 742, homelessness is a growing social challenge. LEAF stepped forward to offer community members the chance to directly impact the life of District 742 students who find themselves homeless and facing challenges few of us have had to face.

The chart shows how the homeless student services funds have been expended.

In addition to the above fund, LEAF provides support to needy students to help pay the costs for participation in extracurricular activities from elementary grades through high school. LEAF has made 21 grants for a total of \$24,109 in support of needy students' participation in the student activities program!



TALENT DEVELOPMENT: LANGUAGE IMMERSION AND ROBOTICS

LEAF grants focus on all academic, activities, arts and athletic programs in District 742. Two areas where LEAF has had an impact are the Chinese/Spanish Language Immersion Program and the Aeronautics program at Tech High School.

LANGUAGE IMMERSION

District 742 has had a language immersion program for several years. The Chinese program is offered at Madison Elementary School and the Spanish Immersion Program is at Clearview Elementary School. In 2014, parents from both programs were looking for a way to raise funds in support of their programs, especially the Amity Program which brings native-speaking individuals from the "home country" to District 742 to work with students in the classroom. LEAF stepped forward and set up an Immersion Fund that includes separate operating funds for both Chinese and Spanish Immersion, and combines an endowment component that supports both funds together. An Immersion committee made up of representatives from LEAF, District 742 administration and both Immersion Programs as well as community representatives meets quarterly to oversee the fund.

ROBOTICS PROGRAMS

Another "talent development" program that LEAF has supported is the district-wide focus on Robotics. LEAF has given grants in support of the extracurricular Robotics Club, VEX Robotics programs in the schools, as well as the STEM/Aeronautics program at Tech High School. A total of 20 grants for \$31,479 have gone to Robotics programming in District 742.

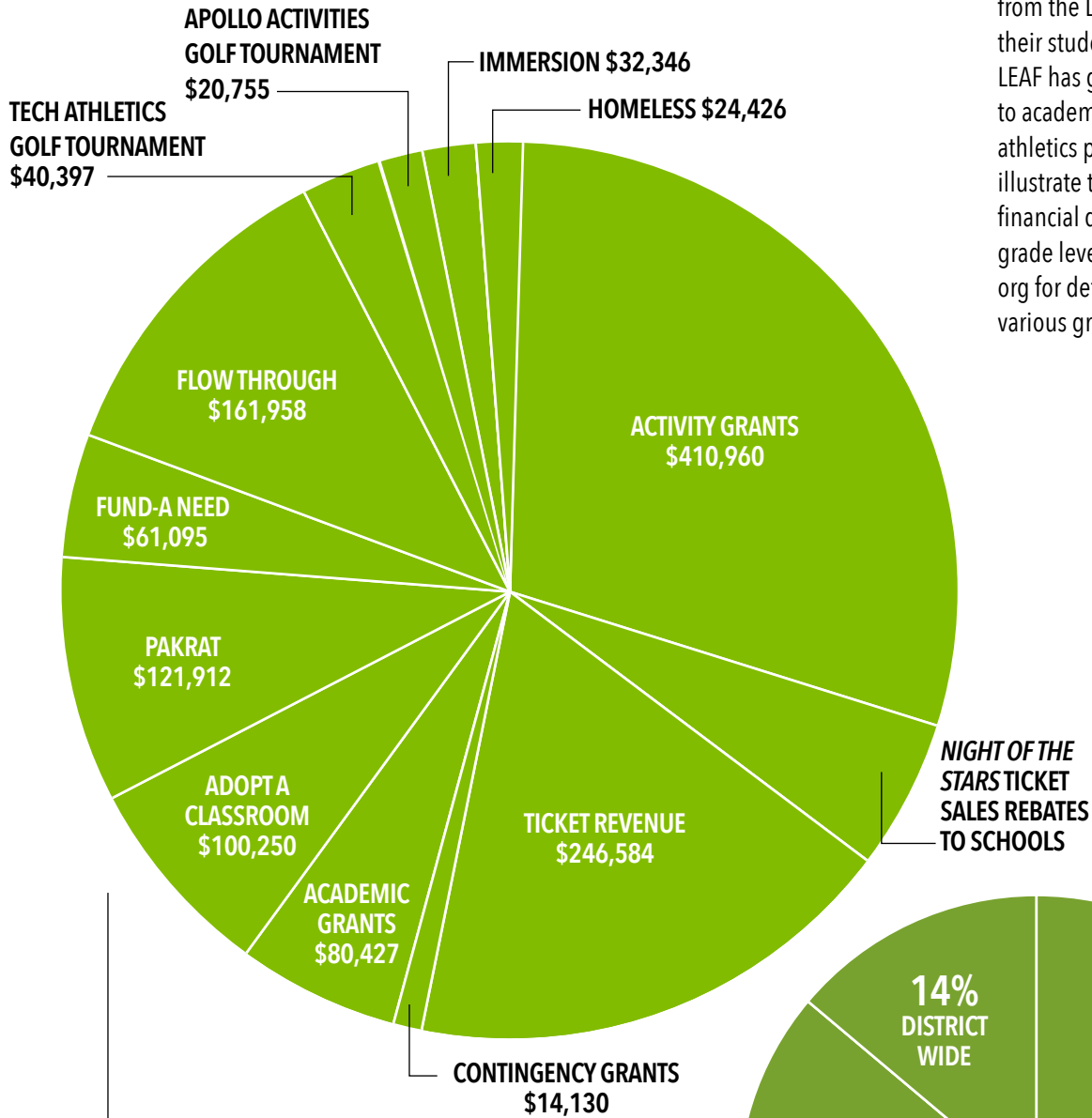

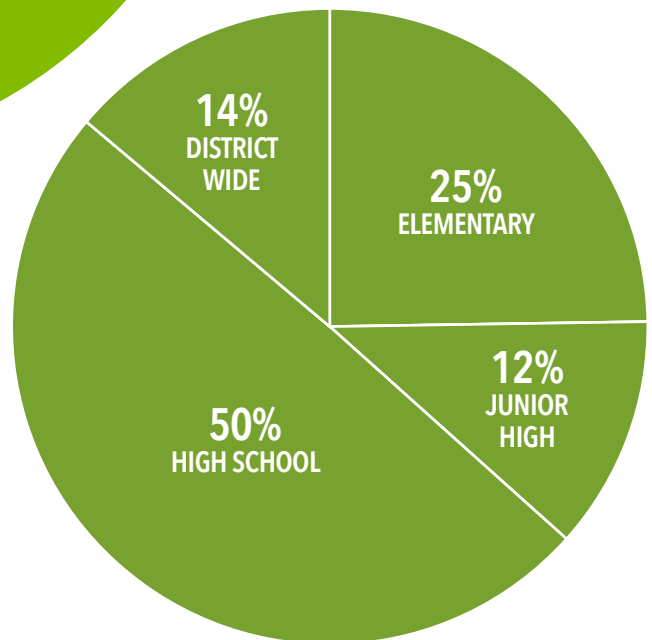

SPECIAL GIFTS SUPPORT LEAF'S IMPACT

During 2016, LEAF received two large anonymous gifts. The first was a \$25,000 gift in support of the PAKRAT Program. This preschool through grade 3 child literacy and parent involvement program has been one of LEAF's great success stories! Since 2011, LEAF has partnered with District 742 to provide early literacy development to meet the District's goal of "All students reading at grade level by third grade." PAKRAT has even been expanded to include a summer component and the purchase of a PAKRAT Bus to deliver the books throughout the district! The program has received local and state recognition.

Our second major gift was a \$10,108 matching grant for funds raised at our Annual LEAF Learning Renaissance "Fund-A-Need." This year one focus of fund-a-need was to provide mobile hot spots for needy students in District 742 middle schools. It was a great success, with a total of \$12,684 donated to just that effort. In addition, because of the generous gift, the Learning Renaissance returned a record amount to the LEAF Academic Fund to benefit all District 742 academic programming!

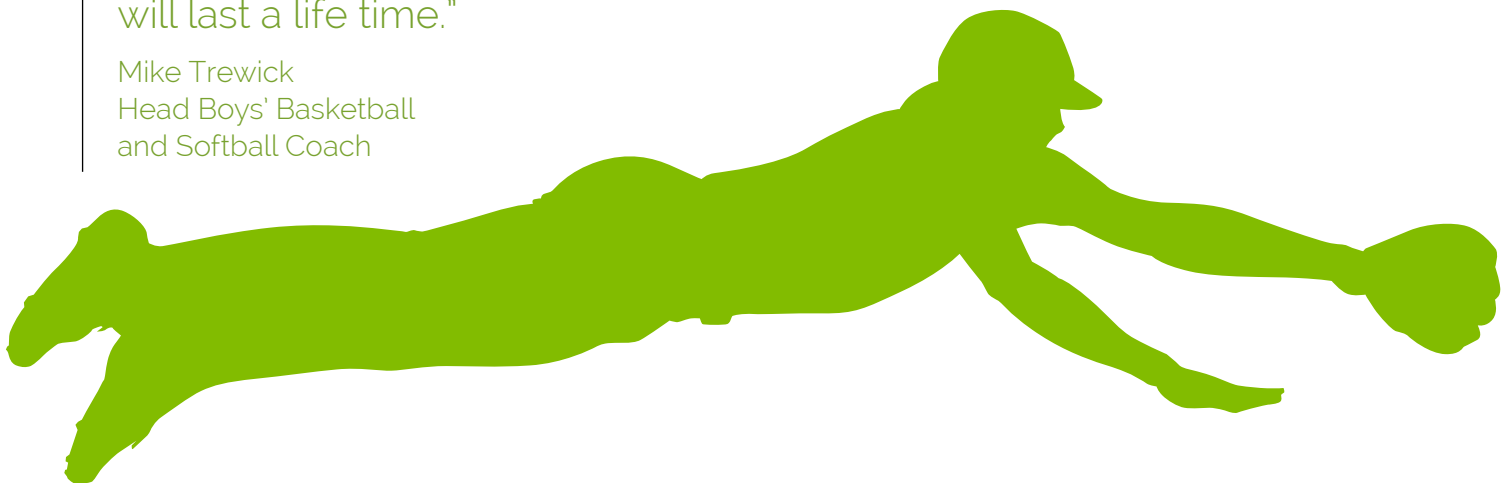
