Additions to agenda:

Financials

Bruce reviewed the Fundraising Report for April 2019

- Legacy Fund Report Bruce shared information about a new fund that has been established by Peggy C and Chuck – it will be spilt between the Participation and the Homeless Funds.

AP Fee for Free/Reduced Lunch Students

As discussed at the April meeting, and noted in the minutes, LEAF is responding to a request to "insure" the coverage of default fees for students on free and reduced lunch who sign up to take the AP exams. This need is the result of changes dictated by the testing service, not the school district. At the April meeting is was decided that the \$2000 usually set aside for academic contingency requests in the spring will be diverted to this purpose. Since the Academic granting round will be moved to fall, this money provided an option. However, the committee asked for historical information about defaults. Bruce shared that information, typically only 4 or 5 students, and it was decided that, even if the date change increased this number, the risk was acceptable.

The Exec committee confirmed that it will recommend support for the request on a one year, trial basis. Funds will be made available by not offering the regular \$2000 academic contingency funding - since there will be a fall granting round added.

It was noted that staff should be made aware of the contingency change along with other notice of the added granting round.

MCN Recognition nomination

The PR Committee completed the application forms and a request was sent to Tami DeLand asking id the nomination can come from the District.

LEAF Photo Contest

The contest is up and running, and will be managed by the PR Committee. No entries have been received to date.
