Financial Reporting:

Nominating Committee: Chuck Provinzino reported.

Joanne has agreed to come back for another 3 years. Pat Welter has not yet responded. Need at least two more. Help with ideas from board. People who want to serve and help with fundraising. Matrix was sent out. Please return. Word doc form now. Email candidates to Chuck.

Looking for a social media committee. Facebook, Twitter, et. al. Have PR committee come up with a recommendation. Ask Don to do a social content calendar? Post articles that are relevant. Every time a grant goes out, etc. We could take out adds on FB. Could we access Tech alumni list to like us on FB? College intern from SCSU? Even high school student. Or a Marco employee who might want to join us and be a leader?

PR Committee Report: Pat Krueger

- Annual fund drive—different approach: printed piece, distinctive and classy, expanded our list again: Tech alumni. Did everyone receive? Commend Don Farleo—nice job!
 Some got more than one. Joanne volunteered to take a look at the list to get rid of duplicates. 8,000 parents alone in district—large! Go through before the merge. \$3,000 have come in so far.

<u>Development Committee Report:</u> Bruce Hentges reported and sent out minutes. Reviewed current events. Didn't recommend any significant changes in events. Gary Marsden recommended a teacher recognition event that is more significant. (Like Naples, FL) Maybe with Renaissance fundraiser? Looked at corporate sponsors and donors. Development comm. thinks this is an area that can be further developed. Solicit donations beyond 1X event. \$10,000 = named fund.

<u>Budget/Finance Committee</u>: Met on Nov. 13th to review form 990. Tom Martin will take us through it in Dec. Our 76% giving ratio is above the standard. Move fiscal year aligned to calendar rather than school year.

<u>November 30</u>: LEAF Appreciation event at Apollo. Play is Spam-a-Lot. If you can't be there that night, let Bruce know for numbers that night.

NOTS: Feb 21 & 22. Met with directors and have set date for auditions.
