1. Call to Order and Additions to the agenda (Vice President <u>Charlie Eisenreich</u>) Meeting was called to order at 4:01 by Charlie E. There were no additions to the agenda.

2. Good News and Thank Yous (Bruce Hentges)

Bruce H. shared that he and Sara Martini attended a meeting at the United Way this afternoon. Everyone who received a grant this year will receive another grant next year with only a 5% decrease in funding. We had received two \$15,000.00 grants this year from the United Way for PAKRAT and PAKCAT. In addition, District 742 has made a large investment in purchasing books for the PAKRAT/PAKCAT programs!

- Fire Truck Ride to Oak Hill for two students at Oak Hill was conducted on May 16 and was a great success! This ride is part of the auction at the annual LEAF Learning Renaissance.
- LEAF thanks Ayan Omar and Jesus Sandoval, two district administrators, for taking a step forward to support LEAF with Dancing With Our Stars Live. Hani Jacobson and Charlie Eisenreich will be their "promoters" at the June 12 event and will come dressed as chips and salsa.
- Bruce H. shared that there has been a total change in our LEAF endowment fund of +\$61,147.23 this year, despite the fact that we have given out over \$50,000 in endowed fund grants since January 1st.
