Learning Renaissance

Elizabeth will call a meeting for next week. Expanding the committee is a goal. Some concerns were expressed about what kind of financial support will be needed or expected for technology. The cost of hardware and service would limit the impact LEAF could make. Consideration of other projects will be on the committee agenda.

Homeless Recent (June) Gifts/Grants

Bruce also reported on a \$5000 potential government grant through the United Way Emergency Food and Shelter Program (EFSP). While this is an opportunity, we may not need it at this time, and the administrative costs could be an issue. Bruce will check into this. Perhaps we can get information about other opportunities in the future.

- 1,500 books from United Way

In addition, The Community Foundation will support the PAKCAT & PAKRAT programs with \$5000, to be evenly divided.

There was discussion of giving away books to children as a substitute for the usual Roll & Read summer program. Gently used donated books are also welcome.

Bruce purposed moving the Stearns donation to Summer Roll & Read program. Since it will not be used for cancelled activity programs. It will then reach children. It was noted that this can be explained to donors as we decide to adjust or move funds around.
